

**Guest Registration Policy**. Any owner who intends to allow another person (a "Guest") to occupy such owner's condominium <u>in the absence of such owner</u> for any overnight period or longer (a "Guest Stay") must register such Guest(s) prior to the Guest Stay, in accordance with this policy. All Guests must fully complete a Guest Registration Form (a copy of which is attached hereto and incorporated herein by reference as Exhibit "A") and submit such application to the Association no less than forty-eight (48) hours prior to the intended Guest Stay of such Guest(s). The Guest Registration Form must identify the Primary Guest (i.e., the Guest who is the point of contact for communications between the Association and Guests). A Primary Guest must be at least eighteen (18) years old. No Guest occupancy of a home may exceed the occupancy limits for that unit. All Guests are subject to and must comply with the Association's Declaration, Articles, Bylaws, and Rules and Regulations at all times while on Xanadu property. Owners are liable for the actions of their Guests.

NOTE: Occupancy is limited to 2, 4, 6 and 8 persons for 1, 2, 3 and 4 bedroom Units, respectively and <u>no pets are allowed.</u>
